On motion of Mr. Lewis, seconded by Mr. McInnis, it was moved to **remove** the following resolution:

RESOLUTION SBPC #1355-07-15

A RESOLUTION TO FILL A VACANT TIRE REPAIRMAN POSITION AT A RATE OF \$11 PER HOUR IN THE ROAD DEPARTMENT.

WHEREAS, the St. Bernard Parish Council passed **ORDINANCE SBPC #1565-10-14** instituting a moratorium on all new hires, except those approved by council by a 2/3 vote of the entire membership.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby allow the hiring of a tire repairman position at a rate of \$11 per hour in the Road Department. The vacancy is the result of the transfer of an employee at \$11.67 per hour into a laborer position previously held by a retiree at the rate of \$12.70 per hour.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
