RESOLUTION SBPC #1357-07-15

A RESOLUTION TO CREATE A DIRECTOR OF IT POSITION TO BE FILLED AT A RATE OF \$70,000.

WHEREAS, the St. Bernard Parish Council passed **ORDINANCE SBPC #1565-10-14** instituting a moratorium on all new hires, except those approved by council by a 2/3 vote of the entire membership.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby allow the creation of a Director of IT position to be filled at a rate of \$70,000.
