On motion of the Chair, without objection and by unanimous consent, it was moved to **remove** the following Resolution:

## **RESOLUTION SBPC #1382-08-15**

A RESOLUTION REQUESTING APPROVAL TO AMEND ITS GUSTAV/IKE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) DISASTER RECOVERY SUSTAINABLE COASTAL COMMUNITIES FISHERIES INFRASTRUCTURE PROGRAM FUNDS IN THE AMOUNT OF \$500,000.00 FOR SUPPORT OF THE ST. BERNARD PARISH DISASTER RECOVERY FISHERIES INFRASTRUCTURE PROJECTS

**WHEREAS**, the Office of Community Development has made available funding in the amount of \$500,000.00 through the Gustav/Ike Louisiana Community Development Block Grant (CDBG) Disaster Recovery Program administered by the Division of Administration to assist St. Bernard Parish impacted by Hurricanes Gustav and Ike in implementing ongoing and planned fisheries infrastructure recovery projects; and,

**WHEREAS**, the St. Bernard Parish Council has through a public hearing process solicited citizen comments relative to the amending of CDBG recovery funds for eligible recovery projects; and

**WHEREAS**, these Gustav/Ike disaster recovery fisheries infrastructure projects are listed by priority and funding as:

**WHEREAS**, the Parish is considering reallocating unobligated funds in the amount of \$ 350,000.00 from the Yscloskey Ice House project. The funds will be de-obligated and returned to the Office of Community Development for reallocation to meet other needs as determined by the Office of Community Development. The Yscloskey Ice House project was deemed to not meet the needs as originally planned therefore the construction was halted as directed by St. Bernard Parish Administration. The remaining funds of \$150,000.00 provided for by the Gustav/Ike Sustainable Coastal Communities Program shall remain obligated as part of the Harbor of Refuge project.
