RESOLUTION TO RECOMMEND AND REQUEST THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT, FEDERAL OFF-SYSTEM BRIDGE PROGRAM TO ADD ONE (1) BRIDGE TO THE 2013-2015 FEDERAL OFF-SYSTEM BRIDGE REPLACEMENT PROGRAM PRIORITY LIST.

WHEREAS, St. Bernard Parish Government maintains this bridge and it is included in the Off-System Bridge Program; and

WHEREAS, St. Bernard Parish Department of Public Works has identified this bridge as a priority for replacement; and

WHEREAS, St. Bernard Parish Government does not have adequate funding for this purpose; and

WHEREAS, it is recommended by the Administration of the St. Bernard Parish Government that the Council approve said resolution.
