## **RESOLUTION SBPC #1394-09-15**

A RESOLUTION AUTHORIZING ACCEPTANCE OF A LOUISIANA COMMUNITY DEVELOPMENT BLOCK GRANT FOR REDEVELOPMENT OF BLUEBIRD PARK IN THE AMOUNT OF \$300,000.00.

**WHEREAS**, the Louisiana Office of Community Development administers disbursement of grant funds for disaster recovery and redevelopment; and,

**WHEREAS**, St. Bernard Parish was seeking grant funding to redevelop Bluebird Park with an emphasis on recreational facilities for special needs children and their families; and,

**WHEREAS**, the St. Bernard Parish Council authorized submission of a grant application to the Louisiana Office of Community Development at its April 21, 2015 meeting seeking \$300,000.00 in order to accomplish this goal; and,

**WHEREAS**, St. Bernard Parish's application for this grant was selected for approval on August 17, 2015; and,

**NOW THEREFORE BE IT RESOLVED** the St. Bernard Parish Council, does hereby authorize the acceptance of this Community Development Block Grant for the Bluebird Park Redevelopment Project in the amount of \$300,000.00; and,

**BE IT FURTHER RESOLVED**, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and execute all required grant agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with this Louisiana Office of Community Development Block Grant Program.
