**AGREEMENT WITH ST. BERNARD PARISH GOVERNMENT TO COLLECT FEE DUE  
PARISHES AND MUNICIPALITIES ON SERVICES OR TRANSACTIONS OF MOTOR  
VEHICLES**

This document evidences that the Secretary, Department of Public Safety and Corrections, and the governing body of the parish, of St. Bernard Parish Government, have agreed, under authority of R.S. 32:429 and under authority of the ordinance adopted by the said governing body effective October 6, 2015 to levy a fee for services rendered by the Chalmette local field office of the Office of Motor Vehicles of the Department of Public Safety and Corrections in St. Bernard Parish, which local field office is not fully funded by the state, to provide that the avails of such fee shall be remitted to St. Bernard Parish Government to be used solely to defray the local costs of the operation of that local field office, specifically including but not limited to, facility rental, utility and maintenance. If a surplus exists, the local field office of the Office of Motor Vehicles, after receiving written approval from St. Bernard Parish Government, will have the option to purchase furniture, equipment, fixtures, supplies, etc. and convert said surplus to recover costs of the local field office operations. In the event that any state legislation is passed that affects this agreement, such legislation will prevail.

It is understood and agreed by the parties hereto that the Motor Vehicle Commissioner shall collect the fee of \$4.50 (\$4.50 maximum) per service or transaction carried out as an operation of the Chalmette local field office of the Office of Motor Vehicles of the Department of Public Safety and Corrections. This fee shall not apply to the procurement or renewal of a motor vehicle registration license.

Any fee levied shall be considered non-state funds and shall be collected by the Motor Vehicle Commissioner on behalf of St. Bernard Parish Government pursuant to this agreement executed by and between the Department of Public Safety and Corrections and St. Bernard Parish Government. Any such fees collected by the Motor Vehicle Commissioner shall be deposited in the state treasury in the Escrow Fund and held for the account of the St. Bernard Parish Government. The Office of Motor Vehicle Commissioner shall distribute any such fees to St. Bernard Parish Government at least monthly.
