## **RESOLUTION SBPC #1414-11-15**

A RESOLUTION TO APPROVE THE CONSTRUCTION OF AN ACCESSORY BUILDING ON PROPERTY OWNED BY THE ST. BERNARD PARISH SHERIFF'S OFFICE, PER THE REQUIREMENTS OF SECTION 5-21. – EXEMPTION OF GOVERNMENT BUILDINGS AND LANDS AND SCHOOLS WITH ENROLLMENT OF 500 OR MORE STUDENTS. PROPERTY IS DESIGNATED AS ONE CERTAIN LOT OF GROUND SITUATED IN ARABI PARK SUBDIVISION, SQ. B, DESIGNATED AS LOT 3. PROPERTY ADDRESS: 1608 AYCOCK ST. ARABI, LA 70032.
