On motion of Mr. Lauga, seconded by Mr. Lewis, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1415-11-15

A RESOLUTION TO APPROVE THE CONSTRUCTION OF AN ELEMENTARY SCHOOL ON PROPERTY OWNED BY THE ST. BERNARD PARISH SCHOOL BOARD, PER THE REQUIREMENTS OF SECTION 5-21. – EXEMPTION OF GOVERNMENT BUILDINGS AND LANDS AND SCHOOLS WITH ENROLLMENT OF 500 OR MORE STUDENTS. PROPERTY IS DESIGNATED AS VERSAILLES SUBDIVISION, SQUARE 239, 240, 241, AND 242.

WHEREAS, the school board is exempt from the Comprehensive Zoning Ordinance by St. Bernard Parish Code of Ordinances Sec. 5-12.

NOW, THEREFORE BE IT RESOLVED, by the St. Bernard Parish Council, to approve construction of the new Meraux Elementary School. Property is designated as Versailles Subdivision, Squares 239,240,241, and 242.

SECTION 1. Severability. If any section, clause, paragraph, provision or portion of this resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this resolution, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.
