NOTE: THE OPERATION OF SOUND- AMPLIFYING EQUIPMENT SHALL ONLY OCCUR BETWEEN THE HOURS OF 8:00 A.M. AND 10:00 P.M. EACH DAY EXCEPT ON SUNDAYS AND LEGAL HOLIDAYS. THE OPERATION OF SOUND- AMPLIFYING EQUIPMENT ON SUNDAYS AND LEGAL HOLIDAYS SHALL ONLY OCCUR BETWEEN THE HOURS OF 10:00 A.M. AND 10:00 P.M.

NOTE: NO SOUND EMANATING FROM SOUND- AMPLIFYING EQUIPMENT SHALL EXCEED THE LIMITS SET IN ORDINANCE SBPC #1256-07-11, SECTION 11-132.

NOTE: IT SHALL BE UNLAWFUL TO OPERATE ANY SOUND- AMPLIFYING EQUIPMENT WITHIN ONE HUNDRED FIFTY (150) FEET OF CHURCHES, SCHOOLS, HOSPITALS, CITY, PARISH, OR STATE BUILDINGS.

NOTE: OBSCENITY PROHIBITED. NO LICENSEE SHALL USE OR PERMIT TO BE EMANATED OR EMITTED FROM ANY SUCH DEVICE, ANY LEWD, OBSCENE, PROFANE, OR INDECENT LANGUAGE OR SOUNDS, OR ANY FALSE REPRESENTATION OF ANY MATTER, PRODUCT OR PROJECT ADVERTISED THEREBY, THE SALE OF WHICH IS PROHIBITED BY ANY LAW, ORDINANCE OR STATUTE.

This application must be signed by authorized official applying for permit. It is understood that any misstatement or suppression of fact in this application or any accompanying documents is grounds for denial of permit.
