## RIGHT of ENTRY St. Bernard Parish Slab Removal Program

**Certification and Agreement:** I certify that I am the owner of the property described above, or am the owner's authorized agent. To help the community and the property, I freely agree to the following for myself and for the owner:

**Right of Entry and the Work:** To allow St. Bernard Parish and the Louisiana Land Trust (and their agents, contractors, and subcontractors) to enter the property and remove any slab or concrete flatwork, and to remove any other items remaining on the property with hurricane damage, such as derelict sheds and fences, trees, or debris (collectively referred to in this document as the "Work").

**Hold Harmless:** To indemnify and hold harmless St. Bernard Parish, the Louisiana Land Trust, and their agents, contractors, and subcontractors, from damages of any type whatsoever, either to the property or to persons thereon.

**Release:** To release, discharge, and waive any action, either legal or equitable, that might arise by reason of any act or omission of the persons authorized to perform the Work.

**Waivers:** To waive all notice, appeal rights, and all other actions, legal or equitable, required or available under law in connection with the Work.

**Underground Features:** To mark any sewer lines, septic tanks, water lines, utilities and any other underground features located on the property that are to be protected.

Non-Duplication of Benefits Certification; Audit: The Work will be paid for by federal Community Development Block Grant funds. Federal law (42 U.S.C. § 5155 et. seq.) prohibits duplication of benefits for losses. The owner of the property has not received money or other benefits for the Work (regardless of the source, including but not limited to federal funds, state funds, grants, or insurance). The owner or I must reimburse the United States, through St. Bernard Parish, to the extent that other benefits have been received or may be received in the future for the Work. Information related to the Work will be shared with other agencies, federal and nonfederal, and with contractors, their subcontractors and employees. The Work and funding connected with it are subject to audit.

**Property of Value Has Been Removed:** All things of value to the owner or anyone having rights to the property have been removed from the property.

**Authorization, not Obligation:** St. Bernard Parish and the Louisiana Land Trust are not obligated to perform the Work; they are merely authorized to do so. The Work is subject to available funding and other work that may have a higher priority, as determined by St. Bernard Parish and the Louisiana Land Trust. in their discretion.

**Expiration:** This Right of Entry shall expire when the Work authorized hereunder is complete, and as long thereafter as necessary for subsequent inspections and closeout activity.

Pursuant to 28 U.S.C. Section 1746 (I/we) declare UNDER PENALTY OF PERJURY that (I/we) own the property, or (am/are) authorized on behalf of the owner(s) to agree to this Right of Entry.
