A RESOLUTION AUTHORIZING A GRANT APPLICATION TO THE LOUISIANA LOCAL GOVERNMENT ASSISTANCE PROGRAM FOR FY2017-2018 IN THE AMOUNT OF \$100,000 FOR PUBLIC WORKS MAINTENANCE EQUIPMENT.

WHEREAS, the FY 2017-18 Louisiana Local Government Assistance Program (LGAP) is a State of Louisiana program designed to provide financial assistance in support of projects which improve the health, safety and quality of life of the residents in selected geographical areas; and,

WHEREAS, St. Bernard Parish is seeking grant funding to provide new equipment for St. Bernard Parish Public Works including new mowing and water and sewer maintenance equipment.

NOW THEREFORE BE IT RESOLVED, that the St. Bernard Parish Council, does hereby authorize the submission of a FY2017-18 grant application to the State of Louisiana Local Government Assistance Program in the amount of \$100,000.00 for Public Works Maintenance Equipment (no local match required).

BE IT FURTHER RESOLVED, that the St. Bernard Parish Council does hereby authorize the President of St. Bernard Parish Government to sign and submit all required grant applications, Cooperative Endeavor Agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with the LGAP Program.


