On motion of Mr. Lewis, seconded by Mrs. Alcon, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1636-09-16

A RESOLUTION OPPOSING THE FLORIDA AVENUE PROJECT IN ITS CURRENT PROPOSED FORMAT.

WHEREAS, pursuant to the requirements of Article VII, Sec. 27 of the Louisiana Constitution of 1974, Act 16 of the First Extraordinary Session of the 1989 Legislature created the Transportation Infrastructure Model for Economic Development program (LSA-R.S. 47:820.2); and

WHEREAS, St. Bernard Parish Government desires to be cooperative with the Louisiana Department of Transportation and Development (LADOTD) and may consider in collaboration with LADOTD a less intrusive rendering of said project; and,

BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, in recurrence with the St. Bernard Parish President do formally request the abandonment of any and all consideration of a grade level extension of Florida Avenue along the south bank of the 40 Arpent Canal.

NOW THEREFORE BE IT RESOLVED, that LADOTD compel Arcadis to amend the current environmental study maps to comply with this resolution and eliminate the grade level Florida Avenue option from further consideration.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
