On motion of Mrs. Alcon, seconded by Mr. Lewis, it was moved to adopt the following resolution:

RESOLUTION SBPC #1638-09-16

A RESOLUTION STATING ST. BERNARD PARISH COUNCIL'S POSITION REGARDING ELECTED OFFICIALS HOLDING A FULL TIME PAID POSITION WITH ST. BERNARD PARISH GOVERNMENT.

WHEREAS, the St. Bernard Parish Council strongly disagrees with the personnel edit changes that was submitted to the Parish Council on September 9, 2016; and,

WHEREAS, the St. Bernard Parish Home Rule Charter specifically states which employees are classified and unclassified; and,

WHEREAS, the St. Bernard Parish Council believes it is not the intent of the home rule charter to allow the Parish President to un-classify any existing employees previously deemed classified; and,

WHEREAS, the St. Bernard Parish Home Rule Charter protects all classified employees and cannot be changed by the Parish President at will; and,

WHEREAS, the St. Bernard Parish Home Rule Charter can only be changed by a vote of the people; and,

WHEREAS, the St. Bernard Parish Home Rule Charter specifically states which employees are classified and unclassified.

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council, the governing authority, strongly disagrees with elected officials holding a full time paid position with St. Bernard Parish Government.


