On motion of Mr. McCloskey, seconded by Mr. Moran, it was moved to adopt the following ordinance:

## ORDINANCE SBPC #2287-01-21

### Summary No. 3861

AN ORDINANCE TO ESTABLISH A SPECIAL REVENUE FUND "TRANSIT BUS SHELTER FUND" AND IMPLEMENT STIPULATIONS FOR ALL ADVERTISING REVENUES AND EXPENDITURES FOR THE TRANSIT BUSES IN THE ST. BERNARD PARISH ANNUAL OPERATING AND CAPITAL BUDGET.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Council, Governing Authority of St. Bernard Parish, does hereby establish a special revenue fund and implement stipulations for all advertising revenues and expenditures on the transit buses for said fund.

**WHEREAS**, the special revenue fund referred to as the Transit Bus Shelter Fund will be established as Fund 236, and;

**WHEREAS**, the revenues for said fund shall come from all advertising revenue fees minus expenditures for the transit buses, and;

**WHEREAS**, any expenditures directly associated with the repair, replacement, or installation of bus shelters for said fund shall go before the full Council for final approval before any expenses are paid, and;

**WHEREAS**, the expenditures from this fund shall only be for the purpose of repair, replacement, or installation of bus shelters in St. Bernard Parish by final approval by the Council.

**SECTION 2.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.


