A RESOLUTION ACCEPTING A DONATION FROM THE ARLENE AND JOSEPH MERAUX CHARITABLE FOUNDATION IN THE AMOUNT OF \$200,000.00 TO FUND THE LA 39: WEST JUDGE PEREZ DRIVE: VEHICLE, PEDESTRIAN, AND BICYCLE SAFETY ENHANCEMENTS THROUGH THE REGIONAL PLANNING COMMISSION.

WHEREAS, this is in accordance with the St. Bernard Parish Comprehensive Land Use Plan to promote the complete streets in our community; and,

WHEREAS, this donation will bring long enhanced safety along the W. Judge Perez corridor by constructing a ten (10) foot wide multi-use side path on the north side from the Guerenger Canal to approximately 9109 W. Judge Perez Dr. near the Guichard Canal and on the south side from the Guerenger Canal to Dr. Meraux Blvd; and,

WHEREAS, this would not be possible with the generosity of the Meraux foundation.

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council, does hereby accept a donation from the Meraux Foundation in the amount of \$200,000.00 to fund the LA 39: West Judge Perez Drive: Vehicle, Pedestrian, And Bicycle Safety Enhancements Through The Regional Planning Commission.


