EXTRACT OF THE OFFICIAL PROCEEDINGS OF THE COUNCIL OF THE PARISH OF ST. BERNARD, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING HELD IN THE COUNCIL CHAMBERS OF THE ST. BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, MAY 2, 2023 AT SEVEN O'CLOCK P.M.

On motion of Mrs. Alcon, seconded by Mr. McCloskey, it was moved to adopt the following Ordinance:

AN ORDINANCE TO AMEND CHAPTER 8; ELECTIONS, SECTION 8-2; SINGLE-MEMBER COUNCILMANIC DISTRICTS; COUNCILMAN-AT-LARGE DISTRICT; ELECTION PRECINCTS TO GEOGRAPHICALLY MERGE PRECINCTS AND INCORPORATE THOSE MERGERS INTO THE REDISTRICTING PLAN ADOPTED BY ORDINANCE SBPC #2451-08-22, AND ESTABLISH POLLING PLACES FOR SAID PRECINCTS.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That Chapter 8 Elections, Section 8-2 of the St. Bernard Parish Code of Ordinances shall be amended and re-enacted as follows:

Chapter 8 ELECTIONS

Sec. 8-2. Single-member councilmanic districts; councilmember-at-large district; election precincts.

- (a) The Parish of St. Bernard is hereby divided into five (5) single-member councilmanic districts lettered A to E, inclusive, in accordance with the provisions of the Home Rule Charter. Each councilmanic district shall consist of the territory presently contained within the several precincts located within such district as described below and the boundaries of each councilmanic district shall be the boundaries of the several precincts that make up the district.
- (b) The councilmanic districts shall be composed of the various precincts of the parish (as set out in subsection (g) hereof) as follows:

- (1) The precincts of District A are 10, 11, 12, 13, 14, and 15.
- (2) The precincts of District B are 20, 21, 22, 23, 24, and 25.
- (3) The precincts of District C are 30, 31, 32, 33, 34 and 40.
- (4) The precincts of District D are 41, 42, 42A, 43, 44, 45, and 46.
- (5) The precincts of District E are 50, 51, 52, 53, 54, and 55.
- (c) Each councilmanic district shall be represented by a single councilmember in accordance with the Home Rule Charter.
- (d) The Parish of St. Bernard shall be divided into two (2) councilmember-at-large divisions, the western division and the eastern division inclusive, in accordance with the Home Rule Charter. Each councilmember-at-large division shall consist of the territory presently contained within the several precincts located within such division as described below and the boundaries of each council-at-large division shall be the boundaries of the several precincts that make up the divisions.
- (e) The councilmember-at-large division shall be composed of the various precincts of the parish (as set out in subsection (g) hereof) as follows:
 - (1) The precincts of the western division are 10, 11, 12, 13, 14, 15, 20, 21, 22, 23, 24, 25, 30 and 32.
 - (2) The precincts of the eastern division are part of Precincts 31, 33, 34, 40, 41, 42, 42A, 43, 44, 45, 46, 50, 51, 52, 53, 54 and 55.
- (f) Each councilmember-at-large division shall be represented by a single councilmember-at-large who shall be elected parish-wide in accordance with the Home Rule Charter.
- (g) The election precincts for St. Bernard Parish are hereby established and the boundaries are prescribed as follows:

- (8)(b) Precinct 15A is hereby geographically merged into Precinct 23.

- (10) **Precinct 23** shall comprise and extend from the intersection of the centerline of West Judge Perez Drive and the centerline of the Chalmette Vista Canal, thence northerly along the centerline of the Chalmette Vista Canal to its intersection with the centerline of Patricia Street, thence easterly along the centerline of Patricia

(20) **Precinct 42** shall comprise and extend from the intersection of the centerline of East Judge Perez Drive and the centerline of Walkers Lane, thence southwesterly along the centerline of Walkers Lane to the intersection with the centerline of East St. Bernard Highway, thence easterly along the centerline of East St. Bernard Highway to the intersection with the centerline of Judy Drive, thence southwesterly along the centerline of Judy Drive to its intersection with the centerline of East St. Bernard Highway, thence westerly along the centerline of East St. Bernard Highway to its intersection with the centerline of Bonner Road, thence southerly along the centerline of Bonner Road to its intersection with the centerline of an unnamed stream, thence westerly along the centerline of the unnamed stream to its intersection with the centerline of Cazzetta Road, thence southwesterly along the centerline of Cazzetta Road to its intersection with the centerline of the Mississippi River, thence southeasterly along the centerline of the Mississippi River to its intersection with the extension of Ingargiola Lane, thence northeasterly along the centerline of the extension of Ingargiola Lane turning into Ingargiola Lane to its intersection with the centerline of East St. Bernard Highway, thence southeasterly along the centerline of East St. Bernard Highway to its intersection with the centerline of Margaret Lane, thence northeasterly along the centerline of Margaret Lane to its intersection with the centerline of Birch Street, thence in a northwesterly direction along the centerline of Birch Street to its intersection with the centerline of Maureen Lane, thence in a northeasterly direction along the centerline of Maureen Lane to its intersection with the centerline of East Judge Perez Drive, thence in a northwesterly direction along the centerline of East Judge Perez Drive to its intersection with the centerline of Judy Drive, the point of beginning.

centerline of the Mississippi River, thence in a southerly direction along the centerline of the Mississippi River to its intersection with unnamed stream (east of Borland Marine Access Road), the point of beginning.

SECTION 2. The precincts merged and the elections districts described herein, shall first take effect, for all purposes, with respect to the regularly scheduled elections in the Fall of 2023. The councilmanic districts in effect on the date of adoption of this ordinance shall remain in effect until the regular elections in the Fall of 2023.

SECTION 3. The polling locations for the amended Precincts 23, 42 and 50 shall be the polling locations already established for those Precincts.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
