## **RESOLUTION SBPC #2297-04-23**

A RESOLUTION TO MAKE AN INTERIM APPOINTMENT TO FILL THE VACANCY IN THE OFFICE OF CONSTABLE WARD "D" FOR THE PARISH OF ST. BERNARD.

**WHEREAS**, the Honorable William "Billy" Cure resigned as of March 31, 2023, creating a vacancy in the Office of Constable, Ward "D", and;

**WHEREAS**, the unexpired term of said office exceeds one year; and,

**WHEREAS**, Ward "D" is wholly located within the boundaries of the Parish of St. Bernard.

**NOW, THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the Governing Authority, does hereby proclaim the following:

**SECTION 1.** That Lester Hueschen Jr. is appointed as Interim Constable Ward "D".

**SECTION 2.** That a Special Election was called at this Council meeting for October 14, 2023, Primary Election and November 18, 2023, General Election with qualifying dates of August 8, 9, & 10, 2023.

**SECTION 3.** The Clerk of Council shall forward certified copies of this Resolution as well as the certified minutes of the meeting by certified mail within twenty-four (24) hours to the Louisiana Secretary of State, and the St. Bernard Parish Clerk of Court in accordance with Louisiana Revised Statutes 18:602.

**BE IT RESOLVED**, that if any provision or item of this Resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this Resolution which can be given effect without the invalid provisions, items or applications and to this end, the provisions of this Resolution are hereby declared severable.
