## **RESOLUTION SBPC #2359-04-24**

A RESOLUTION RESPECTFULLY REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO INSTALL AN INTERSECTION CONTROL BEACON AT THE INTERSECTION OF LOUISIANA STATE HIGHWAY 46 AND ARCHBISHOP HANNAN BOULEVARD IN MERAUX, LOUISIANA.

**WHEREAS**, The St. Bernard Parish Council, the Governing Authority is respectfully requesting the Louisiana Department of Transportation and Development to install an intersection control beacon at the intersection of Louisiana State Highway 46 and Archbishop Hannan Boulevard to promote the health, safety, and welfare of citizens who travel said highway, and;

**WHEREAS**, there has been a total of twenty (20) accidents at this intersection in the past five (5) years, and;

Regarding your recent request for the number of traffic crashes at the intersection of E. St. Bernard Hwy. (La. 46), and Hannan Blvd., I was able to research the following information. For the past five years, from March 2019 to today, March 18, 2024, there have been approximately 20 traffic crashes at this intersection. Of the 20 traffic crashes, the researched information does not explicitly denote if any of the crashes involved injuries or were regular calls for service involving traffic crashes.
