A RESOLUTION SUPPORTING THE FEDERAL AND STATE NEW MARKET TAX CREDIT APPLICATIONS BEING SUBMITTED BY GLASS HALF FULL (L3C) FOR THE PURPOSE OF FINANCING THE EXPANSION OF THE COMPANY'S GLASS RECYCLING FACILITIES IN ST. BERNARD PARISH.

WHEREAS, Glass Half Full (L3C) is considering applying for federal and state New Market Tax Credits to help finance the expansion of the company's glass recycling facilities in St. Bernard Parish; and,

Please find enclosed **Resolution SBPC #2363-04-24**, which was adopted on April 2, 2024 by the St. Bernard Parish Council showing their support of Glass Half Full L3C's (GHF) plans to construct a new and expanded glass recycling center in St. Bernard Parish, Louisiana.

St. Bernard Parish is battling both coastal erosion and an unemployment rate 2.24 times the national average. Coastal restoration is necessary to protect the infrastructure, economy and cultural heritage of St. Bernard Parish. GHF reclaims glass waste that is bound for a landfill and converts it into a variety of useful products, including one that can be used to abate coastal erosion. The new facility will allow GHF to expand their operations which will help reduce landfill waste, restore coastline and create quality and accessible jobs.
