Sheriff Office call to Animal Control, dog on dog attack, report of white pit attacking small dog at Serigne's Boat Launch. small dog received serious injuries, white pit was taken from scene by a man who put the dog in the back of a pickup truck and fled before the sheriff office arrived. ACO Menant responded to sheriff on site by phone who confirmed dog that attacked was not at site, he then spoke with owner of injured dog and confirmed that they were seeking emergency attention at MedVet. Pictures of the injuries were sent to the shelter work phone. ACO Menant received a second call from the sheriff office approximately an hour later stating that the white pit and the person who took him by pickup had returned to the site. ACO went to the site at 5933 Delacroix Hwy, the man and the pit bull were not present, the officer had left the scene the only person there was a man named Jordan Clement who was present and tried to stop the attack, he stated to ACO that he would take responsibility for the white pit. The owner of the dog was someone visiting at his campsite, Jordan had dislocated his shoulder while trying to break up the attack and told ACO he had to leave to seek medical attention.

Statement from owner of injured dog 11/14/16 Jeff Dean ([REDACTED]) & Donna Kiely ([REDACTED]): their dog, a Pomeranian named Taz, was grabbed while being walked on leash by a white pit and was mauled until a man claiming ownership broke the attack and dislocated his shoulder while doing so. Jordan Clement stated that he did not own the white pit but would assume responsibility for the dog's attack, when it was stated that Animal Control would be called to the scene Jordan called to a woman and the white pit was taken from the scene by a man named Jake, no last name available. Donna Kiely and Jeff Dean sought the attention from MedVet for Taz, injuries were extensive, skin was torn from shoulder to shoulder, muscle was torn on back of neck, puncture to front of neck and front of left leg. When returning to site the next morning everyone from the trailer where the white pit was staying that night were gone. A note was left for the owners of Taz with a number for Jordan Clements. Donna Kiely was able to obtain license of trailer E987748, Deputy on scene, Dept. Burns
