Correction Order

Be advised that you have 30 days from the date of receipt of this notice (or the date the notice is posted to the structure) to correct the above listed section violations. Specifically, all damaged roofing, soffit and fascia must be replaced or repaired. All boarding must be removed and windows installed. All electrical equipment and systems (including wiring) must be properly insulated or covered and all graffiti must be cleansed or covered. If any violation is not corrected in twenty (20) days you shall be served an order to appear before the Bureau of Administrative Adjudication for an administrative hearing. Such hearing shall determine the sufficiency of the violation and may result in the placement of all fines, penalties, or other cost onto the properties next *ad valorem* tax bill. Any questions regarding what corrective work is required should be directed to the Office of Resident Services & Compliance at (504) 278-4224 or cdillon@sbpg.net.

11-166.4. *Unauthorized tampering.* Signs, tags or seals posted or affixed by the code official shall not be mutilated, destroyed or tampered with, or removed without authorization from the code official.

If this box [X] is marked with an X, the above outlined corrective work will require that you obtain a permit from the Department of Community Development for St. Bernard Parish Government, commencement of any work requiring a permit without issuance of the permit shall subject you to a minimum of a \$100 dollar fine.

The issuance and enforcement of this notice (and the related code sections) shall have no effect upon, stay or cancel any condemnation hearing, appeal period, condemnation status or demolition proceedings relative to the subject structure.

Violation Penalties

Any person who shall violate the provisions of this code shall be subject to the following fines and penalties:

Upon a first offense – a fine not to exceed five hundred dollars (\$500.00) per each count. In addition to the above set-forth fines, the subject structure shall be subject to demolition. In the event that Parish Government demolishes the structure, the costs for demolition shall be assessed against the property in the form of lien which may be later enumerated onto the annual ad valorem tax bill for the subject property.

NOTE: Each day that a violation continues shall be deemed a separate offense and the applicable fines shall accrue on a daily basis. In instances which a property owner fails to pay fines associated with this notice, St. Bernard Parish Government shall file a lien against the subject property in the amount of the accrued fines. If not paid, the lien amount shall be enumerated on onto the subject properties annual ad valorem tax bill.

Transfer of ownership.

It shall be unlawful for the owner of any dwelling unit or structure who has received a compliance order or upon whom a notice of violation has been served to transfer, mortgage, lease or otherwise dispose of such dwelling unit or structure to another until the provisions of the compliance order or notice of violation have been complied with, or until such owner shall first furnish the grantee, transferee, mortgagee or lessee a true copy of any compliance order or notice of violation issued by the code official and shall furnish to the code official a signed and notarized statement from the grantee, transferee, mortgagee or lessee, acknowledging the receipt of such compliance order or notice of violation and fully accepting the responsibility without condition for making the corrections or repairs required by such order or notice of violation.

Burden of cost

Any costs incurred by Parish Government relative to enforcement of the Property Maintenance Code shall be borne by the property owner. Any unpaid costs relative to this notice shall be assessed against the subject property in the form of a lien against the subject property and/or placed onto the *ad valorem* tax bill for the subject property.

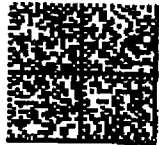

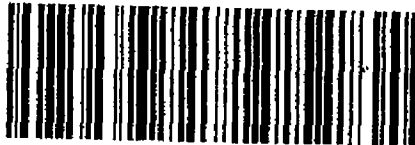
