On motion of Mr. McCloskey, seconded by Mr. Lewis, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1887-11-18

A RESOLUTION DESIGNATING A CERTIFYING OFFICER FOR ADMINISTRATION OF THE LOUISIANA LOCAL GOVERNMENT ASSISTANCE PROGRAM AND THE LOUISIANA COMMUNITY WATER ENRICHMENT PROGRAM.

WHEREAS, the Louisiana Local Government Assistance Program and Community Water Enrichment Program are State of Louisiana programs designed to provide financial assistance to local governments in support of projects which improve the health, safety, and quality of life of the residents in selected geographical areas; and

WHEREAS, the St. Bernard Parish Council approved submission of a FY2018-2019 grant application to the State of Louisiana Local Government Assistance Program in the amount of \$77,800.00 for the Forty Arpent Canal Fishing Pier on July 17, 2018 which was submitted on September 13, 2018; and

WHEREAS, the approving resolution authorizes the Parish President to sign and submit all required grant applications, Cooperative Endeavor Agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with the Local Government Assistance Program; and

WHEREAS, new program regulations require a separate St. Bernard Parish Council resolution designating a Certifying Officer to approve the signature of the Parish President on all payment vouchers and all documents related to requests for payments submitted under the Local Government Assistance Program and Community Water Enrichment Program.

NOW THEREFORE BE IT RESOLVED that St. Bernard Parish Council does hereby designate Ronald Alonzo, Chief Administrative Officer of St. Bernard Parish Government, as the Certifying Officer for purposes of the Louisiana Local Government Assistance Program and Community Water Enrichment Program.
