A RESOLUTION SUPPORTING THE INTRODUCTION AND PASSAGE OF LEGISLATION TO ENABLE ST. BERNARD PARISH TO IMPOSE AND COLLECT A HOTEL/MOTEL TAX TO FUND THE SERVICES PROVIDED BY THE ST. BERNARD PARISH FIRE DEPARTMENT TO HOTELS AND MOTELS.

WHEREAS, the Louisiana State Legislature has the authority to enact legislation that would allow St. Bernard Parish to impose and collect a Hotel/Motel Tax within the confines of St. Bernard Parish to fund the services provided by the St. Bernard Parish Fire Department to Hotels and Motels; and,

WHEREAS, it is in the best interest of the citizens of St. Bernard Parish for the state Legislature to enact legislation authorizing the imposition and collection of a Hotel/Motel Tax in St. Bernard Parish in order to fund the services provided by the St. Bernard Parish Fire Department to Hotels and Motels.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, supports Representative Raymond E. Garofalo, Jr.'s efforts to introduce and pass legislation authorizing the imposition and collection of a Hotel/Motel Tax in St. Bernard Parish of \$3.00 per night, upon a vote of the citizens, in order to fund the services provided by the St. Bernard Parish Fire Department to Hotels and Motels..
