A RESOLUTION AUTHORIZING ACCEPTANCE OF A GRANT FROM ATMOS ENERGY IN THE AMOUNT OF \$4,500.00 FOR THE WIND DOWN WEDNESDAYS CONCERT SERIES IN TORRES PARK.

WHEREAS, St. Bernard Parish submitted a grant application in the amount of \$7,500.00 to the Louisiana Department of Culture, Recreation and Tourism, Division of the Arts' Decentralized Arts Funding Program to fund the Wind Down Wednesday's Concert Series; and

WHEREAS, the Louisiana Decentralized Arts Funding Program notified the Parish it was awarding a grant of \$1,000.00 for this program which the Parish accepted in December, 2018; and,

WHEREAS, ATMOS Energy has provided funding support for this project in the past and was contacted again to request their funding consideration.

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council does hereby authorize acceptance of a grant from ATMOS Energy in the amount of \$4,500.00 for sponsorship of the Wind Down Wednesdays concert series in Torres Park.

BE IT FURTHER RESOLVED, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and execute all required documents in connection with this grant.
