A RESOLUTION REQUESTING AT&T/BELLSOUTH, COX COMMUNICATIONS, ENTERGY, AND LADOTD TO MEET WITH ST. BERNARD PARISH GOVERNMENT ADMINISTRATION AND COUNCIL REGARDING FUTURE CUTTING OF HISTORIC TREES IN ST. BERNARD PARISH.

**WHEREAS**, St. Bernard Parish Administration and Council are requesting to meet with AT&T/BellSouth, Cox Communications, Entergy, and LADOTD regarding future cutting of historic trees in St. Bernard Parish; and,

**WHEREAS**, pursuant to **Ordinance SBPC #2210-11-19**, no person, including public utilities, shall remove any tree or shrub growing within a dedicated street area of public right-of-way or other public property without a permit from the Department of Community Development.

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority, does hereby request AT&T/Bellsouth, Cox Communications, Entergy, and LADOTD to meet with St. Bernard Parish Government Administration and Council regarding future cutting of historic trees in St. Bernard Parish.
