BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON WEDNESDAY, APRIL 15, 2020 AT FOUR O'CLOCK P.M.

On motion of Mr. Everhardt, seconded by Mr. Lewis, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2030-04-20

A RESOLUTION REQUESTING THE CPRA TO ADJUST THE FRESHWATER DIVERSIONS IN AND AROUND LAKE LERY, SPANISH LAKE AND GRAND LAKE AS WELL AS IN THE UPPER ST. BERNARD MARSHES.

WHEREAS, Council is requesting that the salinity levels be kept at 5 to 15 parts per thousands year round; and,

WHEREAS, doing this will control and kill the water lilies that are being used to hatch mosquito larvae; and,

WHEREAS, this issue is causing a perfect breeding ground for mosquitos to multiple which is causing a health and safety issue for St. Bernard Parish.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority, is hereby requesting the CPRA to adjust the freshwater diversions in and around Lake Lery, Spanish Lake and Grand Lake as well as in the upper St. Bernard Marshes.

The above and foregoing having been submitted to a vote, the vote there upon resulted as follows:
