AN ORDINANCE TO **AMEND** CHAPTER 20, TRAFFIC; ARTICLE III, OPERATING REGULATIONS AND STREET DESIGNATIONS; DIVISION 5, STOP AND YIELD INTERSECTIONS; SECTION 20-96 AUTHORITY FOR STOP SIGNS AND YIELD SIGNS OF THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The Parish Council hereby amends Chapter 20, Traffic; Article III, Operating Regulations and Street Designations; Division 5, Stop and yield intersections; Section 20-96 Authority for stop signs and yield signs as attached in Exhibit "A".

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.





Chapter 20; Traffic
Article III; Operating Regulations and Street Designations
Division 5; Stop and Yield Intersections

Section 20-96 Authority for stop signs and yield signs

The Director of Public Works is hereby authorized to erect and maintain stop signs, yield signs, or other official traffic-control devices to designate through streets or to designate intersections or other roadway junctions at which vehicular traffic on one or more of the roadways should yield or stop and yield before entering the intersection or junction.

Stop signs can not be added or removed without letter of recommendation from the Director of Public Works and a resolution approval from the parish Council.
