## ORDINANCE SBPC #2246-06-20

### Summary No. 3812

AN ORDINANCE AUTHORIZING THE TRANSFER OF FORMER LOUISIANA LAND TRUST (LLT) PROPERTIES.

**WHEREAS**, the purpose of this ordinance is to transfer two (2) properties from the Louisiana Land Trust (LLT) to Saint Bernard Parish Government for disposition through the approved plan and authorize transfer of all properties from the Louisiana Land Trust (LLT) that have been acquired by a change from Option 1 to Option 2 or 3.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Parish Council, as the Governing Authority of the Parish, does hereby authorize the St. Bernard Parish Government to receive the Louisiana Land Trust properties listed in Exhibit "A."

**SECTION 2.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.


