On motion of Mr. Everhardt, seconded by Mrs. Alcon, it was moved to **adopt** the following resolution:

## **RESOLUTION SBPC #2055-06-20**

A RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO CONSIDER REMOVING THE ROAD BLOCKS FROM LA 300 FOR FIRST RESPONDER TRAFFIC ONLY.

**WHEREAS**, this roadway will not be open to the public, but Council would like to pursue options to having an electric gate installed on both sides of the closure on LA 300 for access by first responders only; and,

**WHEREAS**, there have recently been issues with response times to house fires in this area; and,

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority, does hereby request LADOTD to consider removing the road blocks from LA 300 for first responder traffic only. This resolution is to be forwarded to Justin Guilbeau with LADOTD.

The above and foregoing having been submitted to a vote, the vote there upon resulted as follows:
