A RESOLUTION APPROVING AMENDMENT 3 TO THE ST BERNARD PARISH RESTORE ACT MULTI-YEAR PLAN.

WHEREAS, the U.S. Congress has passed The Resources and Ecosystem Sustainability Tourism Opportunities and Revived Economy of the Gulf Coast Act of 2011 known as the RESTORE Act; and,

WHEREAS, this Act requires participating entities to prepare and adopt a Multi- Year Plan for the programming of RESTORE Act funds to be approved by the U.S. Treasury Department; and,

WHEREAS, St. Bernard Parish Government has been accepted into this program and did prepare, adopt, and have approved the **St. Bernard Parish RESTORE Act Multi- Year Plan** in June, 2017, Amendment #1 in November 2018 and Amendment #2 in June 2019; and,

WHEREAS, St. Bernard Parish Government wishes to amend this plan a third time in order add two new projects, amend several existing projects, and update the overall program budget; and,

WHEREAS, St. Bernard Parish Government also wishes amend the **St. Bernard Parish RESTORE Act Multi-Year Plan**.

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council does hereby approve Amendment 3 to the St. Bernard Parish RESTORE Act Multi-Year Plan to include the following items as per the attached Plan Narrative:

- Add Bayou Terre aux Boeufs Armoring (\$1,300,000).
- Add Islenos Community Archive at Nunez Community College (\$100,000)

- Amend Central Wetlands Unit Bike Path (previously \$250,000) to exclude the construction of the bike path, include the construction of a pedestrian bridge over Paris Road, and increase the budget to \$1,000,000.
- Amend the Nunez Workforce Development Program to include an additional \$100,000.
- Amend the overall RESTOR Act Direct Component budge to account for all parish allocations through 2026.
