## RESOLUTION SBPC #2076-10-20

A RESOLUTION APPROVING THE PLACEMENT OF A FOUR WAY STOP SIGN AT THE INTERSECTION OF PLAZA DRIVE AND PEOPLES STREET, CHALMETTE, LA.

**WHEREAS**, St. Bernard Parish Council adopted Ordinance SBPC #2240-06-20 at the June 2, 2020 Council Meeting; and,

**WHEREAS**, Ordinance SBPC #2240-06-20 states stop signs cannot be added or removed without a letter of recommendation from the Director of Public Works and a resolution approval from the Parish Council; and,

**WHEREAS**, attached is a letter of recommendation from the Director of Public Works.
