## **RESOLUTION SBPC #2079-10-20**

A RESOLUTION TO APPROVE THE CONSTRUCTION OF AN AT&T CELL PHONE TOWER ON PROPERTY OWNED BY THE ST. BERNARD PARISH GOVERNMENT, ON A PORTION OF GROUND SITUATED IN THE FERNANDEZ SUBDIVISION OF DELACROIX ISLAND, LOTS 99C THROUGH 103C. MORE SPECIFICALLY ON THE DELACROIX SHIPYARD PROPERTY.

**WHEREAS**, pursuant to St. Bernard Parish Code of Ordinances Chapter 5-21, the construction of an AT&T Cell Phone Tower is given the ability to expedite conditional use permit due to being constructed on property owned by St. Bernard Parish Government.

**NOW, THEREFORE BE IT RESOLVED**, the St. Bernard Parish Council, the governing authority, does hereby approve the construction of the new AT&T cell phone tower. Property is designated as the Delacroix Shipyard in the Fernandez Subdivision of Delacroix Island, lots 99C through 103C.
