**WHEREAS**, Valero would like to development a Wildflower Garden on the Northeast corner of Jacob Drive and Missouri Street; and,

**WHEREAS**, Valero would like to improve the beautification and quality of life; and,

**WHEREAS**, Valero's Wildflower Garden shall not fall under the grass ordinance pursuant to Chapter 11 of the St. Bernard Parish Code of Ordinances.
