On motion of Mr. Luna, seconded by Mrs. Alcon, it was moved to adopt the following resolution:

RESOLUTION SBPC #2116-04-21

A RESOLUTION RESPECTFULLY REQUESTING THAT NORFOLK SOUTHERN RAILROAD ADJUST THEIR NIGHTLY RAIL SERVICE SCHEDULE TO DAYTIME HOURS.

WHEREAS, the sound level from the locomotive horn creates a significant noise that often depreciates the quality of life in the surrounding community; and,

WHEREAS, the Parish Council respectfully request that the train schedule be changed to daylight hours, or a Quiet Zone designated between Paris Road and the Poydras Junction; and,

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council, the Governing Authority, does respectfully request that the train schedule is changed to daylight hours or that a Quiet Zone created between Paris Road and the Poydras Junction.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to Marque Ledoux, Vice President of Government Relations of Norfolk Southern Railroad – One Constitution Avenue NE, Suite 300, Washington DC 20002.
