A RESOLUTION TO PARTIALLY RESCIND **RESOLUTION SBPC #2119-04-21**, APPOINTING MEMBERS TO THE BOARD OF ZONING ADJUSTMENTS (BZA) AS IT PERTAINS TO ALISON BARRIOS.

**WHEREAS**, the Council adopted Resolution SBPC #2119-04-21 on April 6, 2021 appointing members to the Board of Zoning Adjustments (BZA); and,

**WHEREAS**, the Council must partially rescind Resolution SBPC #2119-04-21 as it pertains to the appointment of Alison Barrios based on a procedural error and to comply with St. Bernard Parish Home Rule Charter Section 8-03; and,
