On motion of Mr. Luna, seconded by Mr. McCloskey, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2301-05-23

A RESOLUTION RESPECTFULLY REQUESTING ADMINISTRATION TO INVESTIGATE THE USE OF SPEED TABLES AS A METHOD OF CURBING SPEEDING ON FLORIDA AVENUE BETWEEN JACOB AND VAL REISS PARK.

WHEREAS, excessive speeding along Florida Avenue has created an unsafe situation for the residents in said area; and,

WHEREAS, the use of speed tables has been proven to be effective in reducing speeding within neighborhoods; and,

WHEREAS, per Legal Opinion received on October 14, 2019, the Parish has the authority to install speed control devices on public roads.

NOW, THEREFORE, BE IT RESOLVED, by the St. Bernard Parish Council, the Governing Authority, we do hereby respectfully request Administration to investigate the use of speed tables as a method of curbing speeding on Florida Avenue between Jacob and Val Reiss Park.
