BERNARD PARISH COUNCIL VIA ORDINANCE MANDATE ADMINISTRATION TO MOVE FIRE EQUIPMENT AND PERSONNEL THROUGHOUT ST. BERNARD PARISH ACCORDING TO THE ST. BERNARD PARISH HOME RULE CHARTER.

WHEREAS, the St. Bernard Parish Council is respectfully requesting an official opinion regarding whether or not St. Bernard Parish Council, via **Ordinance SBPC #2483-04-23**, can mandate Administration to move Fire Equipment and Personnel throughout St. Bernard Parish according to the St. Bernard Parish Home Rule Charter.

WHEREAS, the St. Bernard Parish Home Rule Charter is attached for your reference; and,

WHEREAS, Ordinance **SBPC #2483-04-23**, an ordinance to have the Administration immediately put back in place the entire staffing and equipment levels of Fire District 2 to its levels as it was prior to March 6, 2023, is attached for your reference.

NOW THEREFORE, BE IT RESOLVED that the St. Bernard Parish Council, the Governing Authority, does hereby respectfully request that Attorney General Jeff Landry provide the St. Bernard Parish Council with an official opinion regarding whether or not the St. Bernard Parish Council, via **Ordinance SBPC #2483-04-23**, can mandate Administration to move Fire Equipment and Personnel throughout St. Bernard Parish according to the St. Bernard Parish Home Rule Charter.
