## **RESOLUTION SBPC #1788-01-18**

A RESOLUTION TO RETAIN TAUZIN CONSULTANTS, LLC AS A FEDERAL LOBBYIST REPRESENTING ST. BERNARD PARISH GOVERNMENT FOR A PERIOD OF ONE (1) YEAR.

**WHEREAS**, the St. Bernard Parish Council, the Governing Authority of St. Bernard Parish has an existing one year contract with Tauzin Consultants LLC to consult on legislative and other matters, which term expired January 10, 2018 (refer to herein as "The Existing Contract").

**WHEREAS**, the St. Bernard Parish Council, the Governing Authority of St. Bernard Parish desires to enter into a new contract with Tauzin Consultants LLC for a one (1) year period to provide direct representation before the Federal Government including Congress, the Administration and various Federal Agencies, along with representation before various State Government Agencies for priority projects, and;

**WHEREAS**, the Council is desirous to retain the services of Tauzin Consultants, LLC, to represent St. Bernard Parish Government for a period of one (1) year pursuant to a new contract and,

**WHEREAS**, the execution of the said contractual obligation is contingent upon the negotiation and review of Councilman Howard Luna and approval of the Council Chair.

**NOW THEREFORE BE IT RESOLVED** that the St. Bernard Parish Council is hereby Authorizes the Council Chair to execute a new one (1) year contract with Tauzin Consultants LLC after the expiration of the one (1) year term of the Existing Contract and after Councilman Howard Luna negotiates and reviews the new contract
