A RESOLUTION AUTHORIZING THE COUNCIL CHAIR TO EXECUTE A CONTRACT WITH THE MUNICIPAL CODE CORPORATION TO REVIEW AND TO PROPOSE REVISIONS TO THE ST. BERNARD PARISH CODE OF ORDINANCES TO MODERNIZE AND CLARIFY THE CODE AND TO ELIMINATE INCONSISTENCIES AND REDUNDANCIES.

WHEREAS, the St. Bernard Parish Code of Ordinances (hereinafter referred to as "the Code") has been repeatedly amended throughout the years;

WHEREAS, the Code has not undergone modernization or a comprehensive review to eliminate inconsistencies and redundancies in more than twenty years,

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby authorize the Council Chair to execute the contract with Municipal Code Corporation, which is attached as Exhibit A
