A RESOLUTION AUTHORIZING AN APPLICATION TO THE LOUISIANA OFFICE OF COMMUNITY DEVELOPMENT TO SPEND COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM INCOME FUNDS ON THE FRESH FOOD RETAILER INITIATIVE IN ARABI IN THE AMOUNT OF \$200,000.00.
