BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, AUGUST 15, 2017 AT THREE O'CLOCK P.M.

On motion of Mr. Luna, seconded by Mr. Montelongo, it was moved to adopt the following resolution:

## **RESOLUTION SBPC #1746-08-17**

A RESOLUTION RESPECTFULLY REQUESTING THE EFFORTS OF STATE REPRESENTATIVE RAYMOND E. GAROFALO, JR., SENATOR SHARON HEWITT AND SENATOR JEAN-PAUL J. MORRELL TO ASSIST THE LAKE BORGNE LEVEE DISTRICT WITH FULFILLING THEIR OBLIGATION FOR THE MAINTENANCE OF THE INTERIOR CANALS IN ST. BERNARD PARISH.

**WHEREAS**, it is the responsibility of the Lake Borgne Levee District to maintain the interior canals in St. Bernard Parish; and

**WHEREAS**, the Lake Borgne Levee District is facing a budget deficit which prohibits them to properly fulfil this obligation; and,

**WHEREAS**, the Lake Borgne Levee District issued election calls in 2014 and 2015 to levy and collect a special ad valorem tax of seven and one-half (7.5) mills for this purpose which was defeated and,

**WHEREAS**, the inability to maintain the interior canals puts the health, safety and welfare of St. Bernard Parish residents at risk.

**NOW THEREFORE BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, is respectfully requesting the efforts of State Representative Raymond E. Garofalo, Jr., Senator Sharon Hewitt and Senator Jean-Paul J. Morrell to assist the Lake Borgne Levee District with fulfilling their obligation for the maintenance of the interior canals in St. Bernard Parish.
