## **RESOLUTION SBPC #1747-08-17**

A RESOLUTION TO PERMANENTLY CHANGE THE POLLING LOCATION OF PRECINCTS 22, 24 AND 25 FROM NUNEZ COMMUNITY COLLEGE TO ARLENE MERAUX ELEMENTARY.

**WHEREAS**, the St. Bernard Parish Council was notified by the Clerk of Court that the current polling location for Precincts 22, 24 and 25, Nunez Community College, 3700 Lafontaine St. Chalmette, LA, St. Bernard Parish, LA will be permanently moved to Arlene Meraux Elementary, 4004 Paris Road, Chalmette, LA; and,

**WHEREAS**, this council shall in a timely manner comply with all provisions of R.S. 18:534 to duly notify all affected persons of the change.

**WHEREAS**, this resolution will replace Resolution SBPC #1737-06-17 that was adopted on June 20, 2017.

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority, does hereby permanently change the polling location of Precincts 22, 24 and 25 to Arlene Meraux Elementary, 4004 Paris Road, Chalmette, LA 70043.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution be forwarded to the LA Secretary of State, LA Commissioner of Elections, the US Justice Department, the St. Bernard Parish Clerk of Court, the St. Bernard Parish Registrar of Voters, Director, Department of Recreation, St. Bernard Parish Government, the Superintendent of the St. Bernard Parish Schools and Bonding Attorney Grant Schlueter.


