A RESOLUTION AUTHORIZING THE REVIEW OF AN APPROVED CONDITIONAL USE AND AN APPROVAL THE UPDATED SITE PLANS (ORDINANCE SBPC #1539-08-14, DATED AUGUST 19, 2014) FOR THE CONSTRUCTION OF A 110-FOOT MONOPOLE TELECOMMUNICATIONS TOWER AT 803 E. JUDGE PEREZ DRIVE, CHALMETTE, LA 70043 (LOT 2, SQUARE L, CHALMETTE PLAZA EXTENSION NO. 2).

WHEREAS, this resolution meets the requirements of Section 22-10-1.3 (h) – Site plan application for conditional uses: Site plan approval shall become null and void in one (1) year from the date of approval if the activities have not commenced and the site plan shall be considered to be disapproved.

WHEREAS, this resolution grants the Parish Council the right to review a previous Conditional Use approval to approve updated site plans for the construction of a 110-foot Monopole Telecommunications Tower due to inactivity greater than one (1) year.
