BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, SEPTEMBER 19, 2017 AT THREE O'CLOCK P.M.

On motion of Mrs. Alcon, seconded by Mr. McCloskey, it was moved to adopt the following resolution:

## RESOLUTION SBPC #1759-09-17

A RESOLUTION AUTHORIZING ACCEPTANCE OF A GRANT FROM THE LOUISIANA DECENTRALIZED ARTS FUNDING PROGRAM IN THE AMOUNT OF \$1,000.00 FOR THE JAZZ IN JUNE CONCERT AT TORRES PARK.

**WHEREAS**, the Louisiana Department of Culture, Recreation and Tourism, Division of the Arts, funds the Decentralized Arts Funding Program which makes grants available to nonprofit organizations, community groups, and local governmental agencies to produce cultural programs; and,

**WHEREAS**, the Decentralized Arts Funding Program issued a call for FY2017-2018 grant applications; and

**WHEREAS**, St. Bernard Parish Council authorized submission of a \$5,000 grant application to fund a second year of the Jazz in June Concert Series by Council resolution in June, 2017; and

**WHEREAS**, limited funding is available for this program and more applications were received than could be funded; and

**WHEREAS**, the Decentralized Arts Funding Program has offered reduced grant funding to St. Bernard Parish Government.

**NOW THEREFORE BE IT RESOLVED** the St. Bernard Parish Council, does hereby authorize acceptance of a grant from the Louisiana Department of Culture, Recreation and Tourism's Decentralized Arts Program, as administered by the St. Tammany Commission on Cultural Affairs, in the amount of \$1,000.00 in order to host the **Jazz in June** concert series in Torres Park including the following additional stipulations:

- this grant provides 100% funding with no local matching funds required by St. Bernard Parish Government
- the Parish may seek additional funding or donations to cover more concerts in the series as it was originally proposed
