Judge Perez Dr. Wal-Mart entrance 393.96' thence p-2 meas. 225' frt. on W. Judge Perez Dr. x same width in rear x depth of 266' = 1.37 acres - Holiday Inn under construction) to be replaced at 309 W. Judge Perez Dr. (lots 5,6,7,8; sq. 101, Vers. Sub. meas. a total of 100' ft. frt. on W. Judge Perez Dr. by a depth of 118' ft. more or less.)


