BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, DECEMBER 20, 2016 AT THREE O'CLOCK P.M.

On motion of Mr. Gorbaty, seconded by Mr. McCloskey, it was moved to adopt the following resolution:

## **RESOLUTION SBPC #1670-12-16**

A RESOLUTION AUTHORIZING ACCEPTANCE OF A GRANT FROM THE ST. BERNARD PARISH MURPHY OIL CY PRES COMMITTEE FOR THE PALMISANO TRAIL IN THE AMOUNT OF \$154,700.00.

**WHEREAS**, the U. S. Department of Homeland Security, Federal Emergency Management Agency is currently providing funding for a drainage project along Palmisano Avenue that will enclose the drainage canal with piping and provide a 10 ft. wide multi-purpose trail on top of the newly enclosed area; and

**WHEREAS**, this bikeway is part of the St. Bernard Parish Bikeways and Trails plan as adopted in the St. Bernard Parish Comprehensive Plan; and

**WHEREAS**, funding is needed to provide the additional elements necessary to legally and safely install the trail including signage, striping, connector trails and transitions; and

**WHEREAS**, this project is located in the Murphy Oil Spill Zone and a proposal was presented to the St. Bernard Parish Cy Pres Murphy Oil Committee to consider funding the additional work needed for the Palmisano Trail in the Fall, 2016; and

**WHEREAS**, St. Bernard Parish Government wishes to certify acceptance of this grant by adoption of this Council resolution.

**NOW THEREFORE BE IT RESOLVED**, the St. Bernard Parish Council does hereby authorize the acceptance of the St. Bernard Parish Murphy Oil Cy Pres Committee grant in the amount of \$154,700.00 for implementation of the Palmisano Trail (no local match required); and

**BE IT FURTHER RESOLVED**, the St. Bernard Parish Council does hereby authorize the President of St. Bernard Parish Government to sign and execute all required grant agreements and any amendments thereof, and all of the necessary reports, requirements, assurances, contracts and any other documents mandated in connection with the St. Bernard Parish Murphy Oil Cy Pres Committee Grant for the Palmisano Trail.


