A RESOLUTION RESPECTFULLY REQUESTING THE EFFORTS OF STATE REPRESENTATIVE RAYMOND E. GAROFALO, JR., SENATOR SHARON HEWITT AND SENATOR JEAN-PAUL J. MORRELL IN THE REPAIR OF BAYOU ROAD IN SAINT BERNARD, LOUISIANA.

WHEREAS, LA 300, Bayou Road, in both directions is closed to traffic until further notice between Purnell Lane and Gnell Drive due to emergency road failure; and

WHEREAS, La R.S.:56:1948.5 designates LA 300 as San Bernardo Scenic Byway; and,

WHEREAS, this route is integral in showcasing St. Bernard's natural beauty and is an important piece of our history and the parish's Tourism industry; and,

WHEREAS, this closure cuts off a major route to our local fisheries and residential homes; and,

WHEREAS, this closure affects the quality of life to citizens as well as emergency response times of the following townships: Saint Bernard, Toca, Kenilworth, Alluvial City, Shell Beach, Hopedale, Delacroix, Verret, Yscloskey, Reggio and Wood Lake; and;

WHEREAS, the St. Bernard Parish Council is requesting that the Louisiana Department of Transportation and Development (DOTD) evaluate this section of Bayou Road and present the Council with a repair plan; and,

NOW THEREFORE BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, is respectfully requesting the efforts of State Representative Raymond E. Garofalo, Jr., Senator Sharon Hewitt and Senator Jean-Paul J. Morrell in the repair of Bayou Road in Saint Bernard, Louisiana and to urge the Louisiana Department of Transportation and Development (DOTD) evaluate this section of Bayou Road and present the Council with a repair plan in a timely manner.
