## **RESOLUTION SBPC #1672-12-16**

A RESOLUTION SUPPORTING THE RECOMMENDED DESIGN OF THE FLORIDA AVENUE PROJECT

**WHEREAS**, pursuant to the requirements of Article VII, Sec. 27 of the Louisiana Constitution of 1974, Act 16 of the First Extraordinary Session of 1989 Legislature created the transportation Infrastructure Model for Economic Development program (LSA-R.S. 47.820.2); and,

**WHEREAS**, St. Bernard Parish Government desires to be cooperative with the Louisiana Department of Transportation and Development (LADOTD) and may consider in collaboration with LADOTD a less intrusive rendering of said project; and,

**BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, in recurrence with the St. Bernard Parish President do formally request the abandonment of current plans to instead consider the recommended changes listed in Exhibit A.

**NOW THERE BE IT RESOLVED**, that LADOTD compel Arcadis to amend the current environmental study to comply with this resolution.
