A RESOLUTION AUTHORIZING ACCEPTANCE OF A GRANT FROM ATMOS ENERGY IN THE AMOUNT OF \$3,977.00 FOR THE JAZZ IN JUNE CONCERT AT TORRES PARK

**WHEREAS**, St. Bernard Parish Council authorized submission of a \$5,000 grant application to the Louisiana Department of Culture, Recreation and Tourism, Division of the Arts' Decentralized Arts Funding Program to fund the *Jazz in June* Concert Series by resolution in May, 2016; and

**WHEREAS**, the Louisiana Decentralized Arts Funding Program notified the Parish it was awarding a grant of \$1,023.00 for this program which the Parish accepted in September, 2016; and,

**WHEREAS**, ATMOS Energy expressed interest in providing funding support and a request was submitted by the Parish to ATMOS in September, 2016.

**NOW THEREFORE BE IT RESOLVED** the St. Bernard Parish Council does hereby authorize acceptance of a grant from ATMOS Energy in the amount of \$3,977.00 for the *Jazz in June* concert series in Torres Park.

**BE IT FURTHER RESOLVED**, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and execute all required documents in connection with this grant.


