A RESOLUTION REQUESTING CONGRESSMAN STEVE SCALISE, SENATOR BILL CASSIDY AND SENATOR JOHN F. KENNEDY AND THE ENTIRE CONGRESSIONAL LEGISLATIVE DELEGATION OF THE STATE OF LOUISIANA TO LOBBY FOR THE FUNDING OF THE NATIONAL SEA GRANT COLLEGE PROGRAM (NSGCP) AT A LEVEL OF \$80,000,000 IN FISCAL YEAR 2018.
